GOLDEN TRAIN set pressured pace, drew away, easily. COUNTESS CAT pressed, chased, 2 path, no match for winner. SUGAR MOON pressed 2 path, held show. EVIL TEMPTATION evennly throughout. CATWALK QUEEN taken back, bid, hung. WHISKARITA unhurried, never a factor. ROTTEN TO THE CORE mid field, through early. JOCKEY OBJECTION 2 versus 4 going to 1st turn was disallowed. JOCKEY OBJECTION 3 versus 4 going to 1st turn was disallowed. STEWARDS INQUIRY going to first turn resulted in no change.
