MISCHIEFS CAUSEWAY was hustled early and dueled from the rail to the second turn, responded to put away FORD FLYER in upper stretch and held gamely. QUICK BUCK was outsprinted but tracked the leaders, bid three wide at the furlong marker and closed steadily to grab the place. FORD FLYER was used early and stalked, moved up to duel outside the winner into the stretch then hung and got tagged for second. CONVEY TO ME lagged for three furlongs then was three wide and closed with interest. WESTERN SIERRA had good speed, dueled for a half mile then weakened. MURLOC BAY tracked the pace from the rail but gave way after a half mile.
