STREET VENDOR was unhurried early, bid into the backstretch the second time, skipped clear and was ridden out to the line. MOUNT PELLIAR had no speed, rallied inside leaving the quarter pole and was along for the place. CAUSE FOR DIVORCE settled for six furlongs, gave a wide rally to the stretch but missed second. LUCKY CODE dropped back early, was fanned four wide and picked off rivals in the lane. BAK TO LIBERTY had good speed, set a pressured pace for six furlongs then was caught and tired. ELEGANT BOY tracked for three quarters then was outkicked and weakened. GOIN' SOUTH was near the pace for six furlongs but gave way in the final eighth. GREAT RUNNER tracked the pace for six furlongs then gave way.
