CREALION (FR) set a clear early pace, kept on late and was best. MASTER SEVILLE was allowed to settle early, loomed late and was second best. PROJECT TWO (IRE) followed the early pace and weakened late. RHYTHMIA was void of any speed and was no factor. NORTHERN THUNDER was reserved early and flattened out. CITY OF GRACE was always outrun. THE STEWARDS POSTED AN INQUIRY AND THE WINNER CREALION WAS DISQUALIFIED FOR A JOCKEYS WEIGHT INFRACTION AND PLACE LAST.
