CAN DO ANDREW chased the leader in the outside up the backstretch, continued around the turn in the three path, kicked clear entering the stretch, and heir that margin to the wire after drifting in in the lane. BABY BOAT raced off the pace on the inside early, came around the turn in the three path, began a bid entering the stretch, raced into traffic in the upper lane and gained ground late from there. CALL ME Q led the way on the inside up the backstretch, navigated the turn from the two path and weakened in the lane. SMOKEN BOY raced in the middle of the pack through the opening quarter, saved ground around the turn and showed no kick. ELI'S PROMISE raced off the pace on the outside early, continued around the turn in the four path and made no bid. HEART N SOUL veered out at the start, lost his rider and later walked off. AND INQUIRY WAS MADE INTO THE START. A SECOND INQUIRY WAS MADE INTO THE UPPER STRETCH CONCERNING THE TOP TWO FINISHERS. UPON REVIEW, NO CHANGES WERE MADE TO THE ORDER OF FINISH.
