SPONGE BATH set a fast pace opening a clear lead on the first turn, widened the advantage down the backside, held the clear lead to mid-stretch, drifted out while tiring late in the drive into the path of the runner-up in deep stretch and prevailed at the wire. MOOGIE SON reserved off the pace racing in a clear pocket to the far turn, commenced a steady bid on the final bend under a long drive, circled five wide closing the gap down the lane and steadied in the final fifty yards as the pacesetter drifted out several paths. MOHTAFIL crowded at the start when sandwiched between rivals, settled near the rear of the strung out field down the backstretch and made a steady advance with a belated bid coming home to be along for the show. RIVER REDEMPTION was bumped and pinballed leaving the gate, raced unhurried for the first three-quarters and showed some late interest down the stretch. LAMPLIGHTER JACK tracked the quick pace through the far turn and weakened in the lane. CONI'S COUP prompted the early pace, chased the leader to midway on the far turn and faded coming home. EVEN THE WIND went evenly failing to menace. VITALE broke outward bothering several rivals leaving the gate and proved a non-factor. SIXWILLBERICH was through early. THE STEWARDS POSTED AN INQUIRY AND BOTH RIDER AND TRAINER OF THE RUNNER-UP

CLAIMED FOUL FOR INTERFERENCE BY THE WINNER LATE IN THE STRETCH DRIVE, UPON REVIEW THE STEWARDS DISQUALIFIED THE WINNER AND PLACED HIM SECOND. THE WINNIN PLACE PIC 8 NUMBERS WERE: 2/4-4/6-3/4-5/7-4/5-4/5/6-3/4-1/2.
