MARY MOONGLOW bumped rival at the start, tracked the early leader two deep, took aim nearing the eighth pole and finished well to edge clear under strong handling. RACING THE LIGHT broke to the outside at the start, bumped rival, sent along to a clear early lead, challenged nearing the eighth pole, kept on but was no match for the winner. CHIQUITA REINA was bumped, shuffled back at the start, Jockey of Chiquita Reina claimed objection for interference at the start against the top two finishers and stewards ruled no change, trailed early on after the poor start, moved up three wide through the far turn, raced five wide into the upper stretch and moved up late to improve position. SHARP ATTACK stalked the pace, raced three to four wide through the far turn and weakened. LIONS LAW dropped back early, saved ground and never threatened.
