## Footnotes | View Glossary Of Terms

DESSERT FIRST rated off the pace outside foes into the far turn, upped the tempo circled the field four wide leaving the quarter pole, long sustained bid went clear under strong handling. LUCY'S LOOKIN LEFT saved ground down the backside, came under urging inside leaving the three eights marker, angled out for the stretch run, never switched leads, along late for the place. ANNIE'S HOPE away in good order, controlled the tempo into the far turn, collared leaving the quarter pole, battled inside rivals through the final sixteenth, conceded settled in for the show. SILKY WARRIOR (IRE) stumble at the start, pressed off the pace between runner down the back stretch, inside through the final furlong, flattened out to the wire. NO NANNETTE NO stalked the pace two wide down the backside, lost ground leaving the quarter pole, under urging four deep had nothing extra late. SIGNATURE STREET saved ground off the pace, never factored through the stretch. JOCELYN wide trip off the pace, eased home.
