BOOTSCUTIN dueled on the early lead between rivals then inside JOJO'S LADY through the turn, kicked clear nearing the lane and moved off under mild urging. JUSTICE IS COMING showed speed along the inside to the turn, angled out then floated six wide into the lane and continued on to well clear for the place. LITTLE BIT JOY stalked the leaders three and four wide, failed to mount a bid but gained the show late. JOJO'S LADY was with the lead group three to four wide, dueled outside the winner in the turn and weakened in the lane. ADDY'S NOVA contested the early lead three wide and tired. VICKY'S CANDY GIRL was slow to begin and trailed throughout.
