SIXES FLY HIGHER bid, in tight late, angled inside. NUBE FIVE BAR no menace. MISS OAKEYE no threat. WELL BALANCED TIME shuffled back early. A steward's inquiry was held concerning the running of the race. A claim of foul was lodged by the riders of SIXES FLY HIGHER and FOXY CARTEL against the rider of CT QUEEN for interference in late stretch. After reviewing the film's, the steward's disqualified CT QUEEN from first and was placed fifth for interference in late stretch.
