TAKILLYA ONTHE HOCKS bumped, forced out. WAGON HIGH bid, no menace. RELAGATE PYC YG bumped, forced in, steadied off heels. DM BELLA STAR in tight, clipped heels, taken up. SOMBRA DYNASTY in tight, clipped heels, taken up sharply. A steward's inquiry was held concerning the running of the race. A claim of foul was lodged by the rider of RELAGATE PYC YG against the rider of EMBERS TIME for interference in mid stretch. After reviewing the film's the steward's disqualified EMBERS TIME from second and was placed last for interference.
