EYE WILL DECIDE bore in turn, bumped, dueled, driving. MASTER REIGNS in tight, taken up, rallied, 3 wide, second best. YIPPEE KI YEY bumped, in tight, shuffled back, 4 wide late. UNLIMITED CANDY bumped, dueled inside, weakened. HONDO HOCKS in tight, shuffled back, 5 wide stretch, no threat. MUSIC DASH unhurried, no menace. DETERMINED in tight turn, taken up sharply, 5 wide turn. EYE B BAD 4 wide, used up, stopped. A steward's inquiry was held concerning the run into the turn. A claim of foul was lodged by the trainer of YIPPEE KI YEY against the rider of EYE WILL DECIDE for interference into the turn. After reviewing the film's, the steward's disqualified YIPPEE KI YEY from third and was placed seventh. Also EYE WILL DECIDE was disqualified from first and place fifth for interference into the turn then was moved up to fourth in the official order of finish.
