RUNAWAY GALILEA strong drive, much best. FAVORITE DASHIN bid, second best. MISS ABRIL bid, no menace. TEXAS CHICKIE no threat. IN EAGLES ARMS taken up start, closed well. P FIRST CINNAMON VV ducked in start, bumped hard. MR CORONA IVORY no menace. MADAME MONROE bumped start. FAMOUS MARCELA no factor. A steward's inquiry was held concerning the start. A jockey claim of foul was lodged by the rider of MADAME MONROE against the rider of P FIRST CINNAMON VV for interference away from the gate. A trainer claim of foul was lodged by the rider of IN EAGLES ARMS against the riders of P FIRST CINN AMON VV and MADAME MONROE for interference at the start. After reviewing the film's, the steward's disqualified P FIRST CINNAMON VV from sixth and was placed eighth for interference away from the gate.
