EYE SHADOW led inside and held sway under a mild drive. DAN'S CANDI GIRL and OCEAN WINDOWS vied outside of the winner but couldn't match strides with that one. CAUMSETT pressed the early pace in the four path, settled but had no late bid. NURSEKRINGLEDANCES was unrushed inside and faded in the stretch. SENSIBLE MARRIAGE stalked the pace in the three path and faded in the stretch. SENSIBLE CHOICE was off awkwardly and trailed.
