UNBRIDLED DEVINE stalked the pace in the four path, bid near the three-eighths pole, dueled briefly in the stretch and drew off near the sixteenth pole under mild handling. RETAIL THERAPY raced well back and had a belated rally for place. SASSY AND BOLD stalked the pace in the five path, bid near the three-eighths pole but couldn't close in the drive. HONEY RED saved ground and had no late bid. SLAM DIEGO stalked the pace in the two path, bid at the quarter pole but faltered in the stretch. SUNNY'S FLAME broke sharply, led in the three path, dueled briefly through the stretch and gave way near the eighth pole.
