SOUND DOCTRINE dueled inside of a rival in the two path and drew off in early stretch under a mild drive. SPOTONJUSTICE dueled outside of the winner but couldn't match strides in the drive. ME AND CHILI stalked the early pace in the four path before fading in the stretch. MR. MELO was bumped at the start, raced well back and improved position late inside. EL ROSILLO passed tired rivals. OPTIMAL COURAGE stalked the early pace in the five path before fading in the stretch. MOR SUCCESS broke inward, raced in the six path and faded in the stretch. C V SHACKLES raced in the four path before fading in the stretch.
