FOREVER GREEDY raced in the three path and gained the show spot late. RAPID JUSTICE saved ground to no avail. SILVER STERLING bid in the three path near the three-eighths pole before fading in the stretch. NEON LEON saved ground to no avail. CREEK VALLEY trailed and offered no bid.
