DELTA TAU CHI dueled outside of a rival, bid near the quarter pole and drew off under a steady drive. HEALING WATERS pressed the pace inside, settled on the turn and had a belated bid inside while no threat. EXPLOSIVELY raced in the three path, bid near the three-eighths pole and faltered in the stretch. CHARBONNAY stalked the pace in the four path, bid near the quarter pole and faltered in the stretch. SOUND DOCTRINE stalked the pace between rivals before fading on the turn. MAXIMUS C dueled inside of the winner before giving way on the turn.
