DAWN AT NORMANDY dueled inside and prevailed under a steady drive. RED STATE dueled outside of the winner and was outfinished. SURLY FURIOUS was bumped at the start, trailed and rallied late in the five path. CUPID'S RUNAWAY bore out at the start, pressed the early pace in the three path, settled and then had no late bid. SHIP SHIP HOORAY was bumped at the start, raced in the three path and offered a mild late bid inside. INVICTUS was bumped at the start, pressed the early pace in the four path, stalked the pace and couldn't close. LATIGO stalked the early pace in the six path, bid near the three-eighths pole and faltered in the stretch.
