LOVING MISCHIEF pressed the pace in the two path, bid near the quarter pole and drew off under mild urging. FOXY JUSTICE saved ground, went to the two path in early stretch, bid but was no match for the winner. CALIFORNIA SMOKE raced in the three path but had no late bid. PRAYER'S BEAUTY led inside and then gave way through the stretch. CALL ME ANGEL bobbled the start, pressed the pace in the three path and faded in the stretch. PETER'S DREAM stalked the pace in the five path, bid near the quarter pole and faltered in the stretch.
