RAMBERT dueled inside, bid near the quarter pole and was clear in the stretch under a mild drive. DAN'S CANDI GIRL saved ground, angled to the four path near the quarter pole, rallied in the early stretch but couldn't get to the winner. LOOKATMYBUCKLE saved ground and rallied in the three path through the stretch. FIRST HILL raced in the three path, bid in the four path through the stretch and faltered late. LOVING MISCHIEF saved ground and had a mild late bid in the three path. WEST MAPLE hopped at the start, raced inside and rallied late in the five path. SUPER STORMY saved ground, then angled to the four path in the stretch for a mild late bid. CAUMSETT raced evenly in the three path. MS TEMPTATION was not a factor. MY BOSSY LADY saved ground to no avail. DON'T BLINK dueled outside of the winner, couldn't match strides with that one and faded through the stretch.
