NINE QUESTIONS was unrushed inside, angled to the six path near the three-eighths pole and rallied strongly under a steady drive. JAILHOUSE JUSTICE raced in the four path, angled to the five path on the far turn, rallied, was impeded slightly near the eighth pole and just missed. TAIL GUNNER bore out at the start, saved ground and rallied late for the show. MACKADOO was bumped at the start, stalked the pace inside, angled to the four path near the eighth pole and bid late. SHIESTY TO CHASE vied in the three path, dueled through the stretch and gave way nearing the sixteenth pole. INCLINED was unrushed inside, bid near the quarter pole but couldn't close late. OSCAR D was bumped at the start, raced in the four path, bid in early stretch and faltered. BRAZILIAN CONEXAO led inside, dueled through the stretch and gave way near the eighth pole. MYSTIK JUSTICE vied between rivals, gave way near the three-eighths pole and was eased in the stretch.
