FERVENT PRAYER stalked the pace in the three path, bid near the half-mile pole, drew off in the stretch under a steady drive and geared down late. HOUSE OF GOLD stalked the pace in the four path, bid near the half-mile pole but was no match. CRAB CRUNCH dueled outside of a rival, bid near the three-eighths pole but couldn't hold off the closers. BENNY'S DAY saved ground, angled to the three path near the quarter pole and faded in the stretch. GIMMEL angled to the four path near the quarter pole but had no late bid. GOOD CIVILIAN saved ground to no avail. ALLBARKNOBITE stalked the pace between rivals before giving way near the quarter pole. CHARLIESLITLDEVIL dueled inside of a rival before giving way near the three-eighths pole.
