POLAR DRIFT saved ground early, angled to the three path near the three-eighths pole, rallied and led late, lasting under a steady drive. OUR JALAPENO bid in the three path near the three-eighths pole, rallied at the eighth pole and just missed. QUAIN was unrushed early, rallied near the three-eighths pole in the five path and just missed. ROCK CITY KID pressed the pace in the three path, bid near the five-eighths pole, dueled inside, was clear in the stretch and was caught. LIGHTING FIGHTER vied between rivals, settled near the five-eighths pole, raced inside but had no late bid. THE KING STINGER saved ground, bid near the three-eighths pole inside, was checked near the sixteenth pole and couldn't close late. JUNKYARD JUSTICE stalked the pace in the four path, bid near the five-eighths pole, dueled outside of a rival and faltered in the stretch. INFINITE SPEED led inside before giving way near the half-mile pole.
