PRAYER'S BEAUTY bore out at the start, led inside, was clear in the stretch and lasted under a steady drive. SHESO ELITE was bumped and taken up at the start, raced in the two path, bid in early stretch and missed. I'MALITTLETHIRSTY broke inward, saved ground, bid near the quarter pole but couldn't close late. JANE PLAIN pressed the pace in the two path but couldn't last. PETER'S DREAM was unrushed and rallied belatedly in the four path. DREAMING GIRL raced in the three path, bid near the quarter pole but couldn't close late. SHESMYHUCKLEBERRY stalked the pace in the three path before fading near the three-eighths pole. THE STEWARDS TOOK NO ACTION AFTER THE RIDER OF SHESO ELITE LODGED AN OBJECTION AGAINST THE WINNER ALLEGING INTERFERENCE AT THE START.
