LIZ'S LEGACY pressed the pace inside, bid in early stretch, dueled and was clear under mild urging. BEBECITA stalked the pace in the four path, dueled in the stretch but was no match late. SARAH'S SMILES broke sharply, led in the three path, vied between rivals in early stretch and gave way. LOTTA LATTE stalked the pace in the five path, bid near the three-sixteenths pole and faltered. THAT'SMYDAUGHTER stumbled at the start, raced in the four path and offered a mild late bid. TIMELESS JUSTICE saved ground to no avail. TOTAL LUNA ECLIPSE stalked the pace between rivals, moved to five wide on the turn and lacked a late bid.
