GO BALI GO stalked the pace in the three path, rallied near the eighth pole and was in time under a steady drive. JAILHOUSE JUSTICE stalked the pace in the two path, bid at the three-eighths pole and led late and was outfinished. LEAVE IT TO KITTEN raced in the three path, angled to the five path near the quarter pole and rallied. NINE QUESTIONS saved ground, angled to the four path near the eighth pole and rallied. DEL MO stalked the pace inside, bid on the far turn, angled to the three path near the quarter pole and was checked soon after. SUMMER LOVER was squeezed back at the start, raced in the four path and bid in the five path in the stretch. ELEVATED GAME stalked the pace in the three path, bid near the three-eighths pole, led between rivals in the stretch and faltered. GRAND ILLUSION stalked the pace in the four path before fading in the stretch. ON PALM SUNDAY dueled outside of a rival and gave way in the stretch. COUNT OF AMAZONIA (IRE) raced in the four path and had no late bid. BOUT TREE FIDDY dueled inside, steadied near the quarter pole and faded. VACCINATOR saved ground to no avail.
