END OF INNOCENCE dueled outside of a rival, bid in early stretch to be clear and lasted under a steady drive. NIXON'S TIME was unrushed early, rallied in the four path on the far turn, pressed the pace late and was outfinished. KAM'S ROCKIN GOLD was clear briefly, dueled inside of a rival and gave way near the eighth pole. CE LA VI CHARLI was through early, pulled up on the backstretch and returned home via the equine ambulance.
