COMPANY YOU KEEP pressed the pace outside of the leader, bid on the far turn, dueled in the stretch and won under a mild drive. MONUMENTALJUSTICE was clear inside, dueled in the stretch and was outfinished. COACH KNIGHT stalked the pace between rivals and faded in the stretch. MANSFIELD TIGER saved ground and faded in the stretch. ME AND CHILI stalked the pace in the three path before fading in the stretch. STAR REVIEW raced in the two path and lacked a closing bid. BLACK WHITE N GOLD raced in the three path and faded in the stretch. LOADEMUPJUSTICE saved ground to no avail. REVS MEDAL hopped and was off slowly, bid in the five path near the five-eighths pole, then faded in the stretch.
