DREAMING GIRL stalked the pace in the four path, bid at the three-eighths pole, vied at the three-sixteenths pole and drew off under a mild drive. ESTRELLA BRILLANTE stalked the pace in the five path, rallied belatedly but was no threat. J'S NAUGHTY KITTEN pressed the pace in the three path, vied in the three-sixteenths but couldn't match strides in the drive. NO TRUST trailed, bid inside near the quarter pole and faltered. HIGHSPEED JUSTICE led inside before fading in the stretch. PASSIONFORJUSTICE hit the gate and was away slowly, bid in the five path near the five-eighths pole, vied in early stretch in the four path and tired from her early efforts. SHESO ELITE stalked the pace inside, angled to the three path near the quarter pole and faded.
