TALENT SHOW stalked the pace in the four path, bid near the three-eighths pole, dueled outside of a rival and was clear late under steady handling. COULDYOUBELOVED dueled inside, was clear briefly in early stretch, dueled but couldn't hold off the winner. FAWN LIEBOWITZ saved ground, angled to the three path in early stretch and had a mild late bid. WEST MAPLE stalked the pace in the three path, bid at the quarter pole in the five path but couldn't close late. AMADORA'S EMPIRE saved ground, bid at the quarter pole and faltered late. LUNAR LACE saved ground, bid at the quarter pole and couldn't

close late. CROWNED WITH GRACE was off slowly, raced inside, bid at the quarter pole and had no late bid. HEARTS UNITED raced in the three path and bid belatedly. CHOATE was unrushed, moved out five wide in the stretch and had a mild late bid. RYE SMILE stalked the pace in the three path, was steadied near the five-eighths pole and gave way on the far turn. SWEET DAYDREAM dueled outside before giving way near the quarter pole.
