JAILHOUSE JUSTICE saved ground, bid in early stretch and was clear under steady urging. WHATDOYOUTHINKMARK hopped and hit the gate, rushed up and drew off early but couldn't last. CALYCANTHUS chased early but had no late bid. MOOGIE SON raced in the four path and bid belatedly. GO BALI GO raced in the three path and faded in the stretch. ACCREDIT was not a factor, pulled up near the three-eighths pole and returned home in the equine ambulance.
