BRIGHT SPARK took back inside, rallied in the four path at the three-eighths pole, dueled through the stretch, drew off at the eighth pole and geared down late. COMPANY YOU KEEP stalked the pace in the three path, bid near the half-mile pole, dueled inside the winner but was no match. MANSFIELD TIGER stalked the early pace in the two path, bid near the three-eighths pole and faltered in the drive. TAPAKENA was clear early inside and gave way on the turn. NACHO CHROME raced between foes, saved ground on the far turn and faded in the stretch. FIERCE ASSAULT was no factor. LOADEMUPJUSTICE saved ground to no avail. FOREVER LASTING was not a factor. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
