SHESHOIS was clear early, dueled in the stretch, coming in slightly near the sixteenth pole and prevailed under a steady drive. WELL HEY THERE was bumped at the start, saved ground, rallied near the quarter pole, dueled, steadied slightly in the stretch and was outfinished. CLOUDLESS DAY stalked the early pace in the three path and faded near the quarter pole. ATHENA THE SWIFT bore out at the start, stalked the early pace in the two path and faded in the stretch. GO EVE GO bore out at the start and passed tired rivals. NANCY C hopped at the start, raced in the four path and faded on the turn. GONE TO FAR lost all chance when she stumbled badly at the start, saved ground, managed a bid near the quarter pole but faltered in the stretch. THE STEWARDS TOOK NO ACTION ON A COMPLAINT LODGED BY THE RIDER OF WELL HEY THERE AGAINST THE WINNER ALLEGING INTERFERENCE IN THE STRETCH.
