GOODLOOKINJUSTICE led inside, was clear on the turn and drew off while kept to task. LATIGO pressed the pace in the two path but was no match in the stretch. MOLLY'S TOWN stalked the pace inside and had no late bid. SCOTTY'S ON EDGE raced in the two path and had a mild late bid in the three path. COMMANDER STORM raced in the three path and improved position late. TAILLIGHTS bumped with a rival at the start, stalked the pace in the three path and gave way near the quarter pole. NEUTRON bumped with a rival at the start, stalked the pace in the four path and gave way on the turn.
