MY MILEY'S VOW broke outward, trailed, bid inside near the three-eighths pole, angled to the four path in early stretch, rallied and was kept to a mild drive. JACKSON'S BUDDY vied in the four path, bid late but couldn't hold off the winner. AMIGOMEISTER vied in the two path but couldn't hold off the closers. GIMMEL stalked the pace in the three path, angled to the five path in the stretch and had a belated bid. CRAB CRUNCH vied inside and gave way late. REV'S MUSTER was bumped at the start, raced in the four path and gave way in the far turn. BITOFJUSTICE vied in the three path and gave way on the far turn.
