CASTLE MAGIC dueled outside of a rival, drew off near the eighth pole and held sway under mild urging. WHEN'S FOREVER stalked the pace in the three path but couldn't match strides late. EVIL INTENTIONS stalked the pace in the two path and had no late bid. D' KITTEN dueled inside and gave way in the stretch. SKYS IMAGE stumbled at the start and trailed.
