BASIL stalked the pace in the two path and had no late bid. PRO FEVER stalked the pace inside and faded in the stretch. GEOLE pressed the pace between rivals and faded late. MR SLEDGE HAMMER raced evenly in the four path. UNBRIDLED INTENT was bumped at the start and saved ground to no avail. SPEEDY SPIRIT stalked the pace in the four path and faded in the stretch. MOST AMAZING was bumped at the start

and saved ground.
