The purse will be divided 55% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth, 1.5% to seventh and eighth and 1% to ninth and tenth. The top 10 fastest qualifiers in the trials will remain eligible to the Governors Stakes Final on October 25. Assistant Starters will be provided for the competitors.
