BOITANO stalked the pace in the three path, angled to the four path near the quarter pole, rallied and was in time under steady urging. DRIFTWOOD

dueled inside, was clear in the stretch but couldn't hold off the winner. NACHO CHROME raced in the three path and rallied strongly in the five path. KYGO (GER) stalked the pace inside and bid late. SCENIC JUSTICE bore in at the start, stalked the pace in the three path and rallied belatedly. HOLD YOUR APPLAUSE was off awkwardly, trailed and rallied belatedly in the five path. HYDRO FROST dueled outside and gave way in the stretch. LEAVE IT TO KITTEN saved ground, steadied near the quarter pole and faded in the stretch. ANCHOR MANNE was impeded at the start, raced inside and faded in the stretch. NOW AND LATER was not a factor. COMPANY YOU KEEP stalked the pace inside before giving way near the half-mile pole.
