FIELD DAY dueled outside of a rival, bid at the eighth pole to be clear and held sway under mild urging. DECATUR STREET was brushed at the start, raced in the three path, bid at the three-eighths pole but couldn't get to the winner. ZAPPINIT dueled inside of the winner and was no match, fading at the eighth pole. J J'S RANGER pressed the early pace inside and faded on the turn. NEOKING raced in the five path and had no late bid. MISTER KELLY was brushed at the start, raced in the five path and faded in the stretch. T. L. COPPER STILL saved ground to no avail.
