FOXY JUSTICE was bumped at the start, settled, rallied in the six path near the quarter pole and was clear under steady urging. SHE'S A WHIRLWIND broke through the gate prestart, was reloaded without incident, bore out at the start, settled, rallied inside near the three-sixteenths pole but was no match for the winner. LUNA DIVA dueled inside of a rival and couldn't hold off the closers. PETER'S DREAM was bothered when a rival broke through the gate prestart, settled down, raced in the four path and had no bid. PRAYER'S BEAUTY dueled outside of a rival and faded near the eighth pole. SHESMYHUCKLEBERRY raced in the three path and had no late bid.
