EVANESCENCE stalked from the four path, pressed the top pair around the turn, sustained her challenge while moving out to the six path in midstretch then drove past with a sixteenth to go. BEYOND BELIEF set a pressured pace in the two path, brushed with an outer prompter while dueling in upper stretch, battled into the final furlong then repelled her counterpart whlie getting outkicked by a wider challenger at the sixteenth pole. LYNN'S MILKY WAY prompted from the three path, then between horses around the turn, brushed with her inner counterpart while dueling in upper stretch then yielded to the top pair leaving the sixteenth marker. ROSWELL raced close up along the inside, steadied while tugging inside of the leader leaving the nine sixteenths pole, settled into stalking stride into the turn then lacked a bid. SHOTGUN WEDDING trailed in the two path then got outrun.
