JOCKEY'S OBJECTION, RIDER OF CALL ME SUSIE CLAIMED FOUL ON TIGER FIRE, AFTER REVIEW THE STEWARDS RULED TIGER FIRE WAS NOT RESPONSIBLE FOR THE TROUBLE ENCOUNTERED BY CALLE ME SUSIE
