PROOF HE'S FAST broke out/bumped start, sent clear, ridden out. MAGILLIGAN chased 2wide, willingly 2nd 3path. KARMA'S REVENGE shifted in start, chased inside, outfinished for 2nd. BAIL ME OUT PATTY chased 3wide, one paced inside. TONY'S FEVER bumped out/took up start. GREAT STRIKE bumped out start, stalked 3path, no threat. BUCKY'S BOY stalked inside, no rally 4path. STEWARDS INQUIRY INTO THE START OF THE RACE, AFTER REVIEW, KARMA'S REVENGE WAS DISQUALIFIED AND PLACED FIFTH FOR INTERFERENCE AT THE START
