FEISTY MITOLE steadied early, stalked inside. GOLDEN AND BLUE dueled 2wide, weakened. FUNKY GREY avoided rival early, 4path, no bid. UR IN TROUBLE away well, crowded/clipped heels early, lost rider, walked eq amb. STEWARDS INQUIRY, AFTER REVIEW, QUEEN OF THE TRACK WAS DISQUALIFIED AND UNPLACED BEHIND UR IN TROUBLE FOR NOT HAVING SUFFICIENT CLEARANCE AND CAUSING A SPILL
