BLINKNUMISSIT stalked the pace, rallied on the turn, challenged for the lead entering the stretch, dueled in tight quarters and drew clear in the final strides. UNSHAKEABLE PROOF was away alertly, set the pace, responded when challenged to duel, came out under left handed urging to be in tight quarters and was taken up near the wire. LOUISIANA BARGAIN was never far off the pace, raced outside, lacked a late response and held for show. BOX OF CANDY was void of early speed, went widest in the drive and found his best stride late. LT. TENT was slow early, bid three wide entering the stretch, lacked the needed rally and failed to menace. TITO brushed at the start, stalked the pace along the inside, stopped into the turn and was not urged late. MO'Z STAR TARGET showed little. The stewards' posted an inquiry and the rider of UNSHAKEABLE PROOF lodged an objection against the rider of BLINKNUMISSIT for alleged interference in deep stretch. No change was made.
