FOXTROT HARRY lagged early, rallied around the turn, went seven wide entering the stretch, bid willingly, dueled to deep stretch and inched away to prove best. CUSTOM'S CLEARED brushed at the start, raced close to the pace, bid willingly to duel for the lead and yielded late, grudgingly. PEGASO was unhurried early, saved ground, angled out into the turn, bid eight wide, found his best stride late and was gaining ground. GORILLA TREK raced close to the pace, lacked the needed late response and failed to improve. FRAN'S STAR pressed the pace while racing well off the rail, swung out entering the stretch,

weakened in the drive and faded from contention. RUNNIN MUNNIN brushed at the start, set a pressured pace to mid stretch and was unable to sustain his bid. COURAGEOUSLY raced mid pack, saved ground, bid along the rail on the turn and came up empty. MOMENT OF STARDOM was outrun in an even effort. SUMMER LOVER was through after a half. BERNIN TUNE was not a factor. PUBLIUS was through early.
