CAJUN ACES away in good order, relinquished the advantage past the wire the first time, prompted that one from along the inside the opening half, idled while covered up in traffic into the far turn, saved ground into the lane, moved out, split foes past the furlong marker to challenge, led late, nailed by the winner in the final jump. LIL ASHLEY B. off a step slow, moved up to race behind the leaders through the first turn along the inside,moved out a bit and moved closer in the two path far turn, shifted out for the drive, set down, closed with good resolve to be up in time. CLEARLY BELLA forwardly placed while off the inside, advanced final turn, took over entering the stretch, showed the way past the furlong marker but failed to contain the top two while between that pair at the wire. WORLD OF HURT lacked speed while between horses through the first turn, dropped inside, saved ground through the second turn, went evenly through the stretch in lacking a closing response. MAXIMUM MOXIE hesitated at the break to spot the field a couple of lengths, lacked speed, three wide into the lane, also lacked a closing kick. RUN BAMBI RUN took command soon after the start, showed the way through the first turn in the two path, continued to set the pace up the backstretch, dueled with CLEARLY BELLA late in that bend then faltered when headed by that one entering the straight. COUNTRY BELLE in mid pack while three wide first turn, two path second, had nothing for the drive. ANN'S STORM off slowly, raced four wide through the first turn when well off the pace, was finished after a half.
