SARAH'S COURT stalked the pace, moved up three wide through the far turn and finished well to draw clear under strong handling. FLASH MASTER was off slowly, moved up four wide around the far turn and finished gamely to the wire. PRINCESS KAIULANI dropped back early, saved ground through the far turn, swung five wide and had not enough. MY LIGHTNIN BOLT vied for the early lead along the inside and weakened. GIRL LIKES BLING vied for the early lead and stopped. This race had a timing discrepancy or malfunction, and it was re-timed using video technology to obtain the most accurate final time available. Internal fractions have been removed and are not available.
